# STATUTES

## TITLE I

CONSTITUTION - NAME - HEADQUATERS - DURATION – SUBJECT

### ARTICLE 1 : CONSTITUTION

It is constituted between those who adhere to the present statutes, an NGO governed by the law n° 60-315 of September 21st, 1960 relating to the NGOs.

### ARTICLE 2: NAME

The NGO referred to in Article 1 is called: **Coeur de Rose**. It is the non-governmental and humanitarian organization of the **Federation of Young Socialists of Ivory Coast**

The Federation of Young Socialists of Côte d'Ivoire is an autonomous organization of young people whose main missions, like all the movements of young socialists and progressives throughout the world; is to train young people in the values of citizenship such as democracy, solidarity, sharing, the fight against social discrimination

### ARTICLE 3: DURATION

The NGO is established for an indefinite period

### ARTICLE 4: HEADQUATERS

The headquarters of Coeur de Rose is located in Abidjan Cocody Angré 22e Arrondissement building Oly jeans Apartment 14. PO Box 08 BP 890 ABIDJAN 08.

It may be transferred to any other place if necessary by decision of the general assembly.

### ARTICLE 5: OBJECT

The object of the association is the following:

- Promote peace
- Fight for justice and equality
- Fight for freedom
- help the poor in Côte d'Ivoire in Africa and in the world;
- Defend the rights of children
- Promote international solidarity

### **ARTICLE 6: QUALITY OF MEMBER**

The NGO is composed of active members and honorary members

- Can be admitted as active members, any person in accordance with the statutes. Anyone wishing to promote peace, democracy, freedom, justice, children's rights, education, environmentalism
- Who paid their dues and who regularly pays their annual dues
- children and girls have priority over all other applications for membership
- Admitted as honorary members, those who have rendered or are likely to render exceptional services to the NGO

### **ARTICLE 7: LOSS OF QUALITY OF THE MEMBER**

Membership is lost through:

- Resignation
- The death
- Dissolution
- exclusion for attitude contrary to the values defended by the NGO

## **TITLE III**

### **ADMINISTRATIVE ORGANIZATION OF THE ASSOCIATION**

The NGO has the following organs

- The General Assembly
- The Board of Directors
- The Statutory Auditors

## **CHAPTER I: THE GENERAL ASSEMBLY**

### **ARTICLE 8: THE GENERAL ASSEMBLY**

**Ivory Coast Socialist Youth Federation**  
**NGO CŒUR DE ROSE**

The general assembly is the supreme decision-making body of the association. It is described as ordinary or extraordinary according to the purpose of its deliberations

#### **ARTICLE 9: COMPOSITION**

The general assembly is composed of the members of the board of directors, the statutory auditors and the active members

#### **ARTICLE 10: POWERS**

The general assembly defines the general policy of the NGO. It elects the members of the Board of Directors and the Statutory Auditors and terminates their duties under the conditions provided for by these articles of association.

the general Assembly:

- Sets the contribution rate and allowances to be allocated to the members of the Board of Directors and the Statutory Auditors
- Hear reports from the board of directors and auditors
- Discuss and approve the balance sheet and the account for the completed fiscal year
- Give annual or final discharge to the board of directors
- Pronounces the definitive exclusion of members or their resignation
- Gives power to the board of directors to perform all management tasks
- Decides on the modification of the statutes, approves the rules of procedure
- Pronounces the dissolution of CŒUR DE ROSE and defines the terms of the transfer of the property, the anticipated dissolution, the transfer of the seat in a locality, the change of name of the association, the modification of the composition of the general assembly and the Board of Directors and any permanent modification and extension of the powers of the Board of Directors

#### **Article 11: Decision making**

all decisions must be collegial and democratic.

no harassment should be done against children and girls.

the opinions and proposals of children are considered in the same way as any other opinion and proposal

#### **ARTICLE 12: PERIODICITY OF MEETINGS**

The general assembly meets once in the first quarter of each year in ordinary session on convocation of the president of the board of directors

In the event of absolute incapacity of the president noted by the general secretary, this one informs the members of the board of directors by mail. As a result, the General Secretary convenes the general assembly or, failing this, the Board of Directors convenes the general assembly.

It meets in extraordinary session at the request of the Board of Directors or 2/3 of its active members to deliberate on a specific agenda

#### **ARTICLE 13: QUORUM**

The general assembly, to deliberate validly, must be composed of 2/3 of its active members. The deliberations are taken by the majority of the votes of the members present or represented.

Nobody can have more than two powers, including his own

**ARTICLE 14: PRESIDENCY**

The meetings of the Ordinary or Extraordinary General assembly are chaired by the President of the Board of Directors of CŒUR DE ROSE or by a President designated from among the participating active members.

**CHAPTER II: BOARD OF DIRECTORS**

**ARTICLE 15: BOARD OF DIRECTORS**

The board of directors is the management and administrative body of the NGO. He acts in accordance with his own powers and those delegated to him by the general meeting

The Board of Directors of Coeur de Rose consists of:

- The presidency composed of the president and two vice-presidents
- The General Secretariat composed of the Secretary General and 2 deputies
- Secretariat of the Organization composed of the Secretary of the Organization and 2 deputies
- The General Treasury composed of the Treasurer General and 2 deputies
- The Resources Secretariat composed of the Secretary RESOURCES and 2 deputies
- Access and Volunteer Secretariat composed of the Secretary of the Members and 2 deputies
- Secretariat of Communication and Partnerships composed of the Secretary of Communications and 2 deputies
- the Secretariat for Social and Cultural Affairs composed of the Secretary for Social and Cultural Affairs and two deputies
- 3 special advisors

The Bureau of the Executive Board should move towards gender parity and include children

**ARTICLE 16: MODE OF VOTING**

To be a presidential candidate for COEUR DE ROSE Board, you must:

- be a member of the Board of Directors of COEUR DE ROSE to date of his contributions
- the General Assembly elects the President of Coeur de rose by secret ballot and by absolute majority
- If, in the first round, no candidate has been able to obtain the required majority, a second round is organized by simple majority with the two (02) highest ranked candidates.
- In case of a tie, only children and girls will vote
- In case of a draw, a draw is organized

The counting will be done on the spot and in the presence of all the members of the polling station

the announcement of the results will be made by the president of the polling station to the general assembly as soon as the counting is finished

the president of COEUR DE ROSE is elected for 2 years. He can be re-elected once

#### **ARTICLE 17: COMPOSITION**

the Board of Directors of CŒUR DE ROSE is composed

A Presidency, a General Secretariat, a General Treasury, an Organizing Secretariat, a Resource Secretariat, a Membership and Volunteering Secretariat, the Communications and Partnerships Secretariat; of the Secretariat for Social and Cultural Affairs, Special Advisers

In the event of exclusion, resignation, death or absolute incapacity of any of its members, the Management Board may at any time complete the limits set out below, unless confirmed by the general assembly.

#### **ARTICLE 18: MANDATE OF THE BOARD OF DIRECTORS**

The executive board is elected for two years. Members are re-eligible.

#### **ARTICLE 19: POWERS OF THE BOARD OF DIRECTORS**

The board of directors is vested with the broadest powers to act in all circumstances on behalf of the NGO. It

Discusses all common questions

- Establish the annual inventory, balance sheets and accounts and draft any document that may be submitted to the general meeting;

- Submit a report of activities to present to the general assembly and make proposals

Convenes the general meeting and decides on the draft agenda;

- Executes the decisions of the general assembly;

- Determine the investment of available funds

- Authorizes any withdrawal and transfer of funds belonging to the association with or without guarantee;

- Proceed to install COEUR ROSE sections;

- Establishes the rules of procedure of the association and submits them to the approval of the general assembly

The aforementioned powers of the Executive Council are stated and not restrictive. The General Assembly may restrict or delete them

#### **ARTICLE 20: MEETINGS**

The board of directors meets once a month from the day of its creation and as many times as necessary at the request of 2/3 of its members on a specific agenda.

#### **ARTICLE 21: QUORUM**

The deliberations of the board of directors are only valid if 2/3 of the members are present. Voting takes place by simple majority; the presidential vote being preponderant in the event of a tie

## **ARTICLE 22: COMPOSITION OF THE AUDITORS**

The General Meeting elects, under the same conditions as those of the Board of Directors, two auditors for a period of two years. They are re-eligible twice

## **ARTICLE 23: ATTRIBUTES OF THE AUDITORS**

The Statutory Auditors examine the annual accounts and prepare a special report to the General assembly together with their observations and proposals. For this purpose, the books, the accounts and generally all the writings must be communicated to all the requisitions.

They can at any time check the status of the fund.

They fulfill their missions within the general framework of the laws in force.

## **TITLE IV: FINANCIAL AND BUDGETARY RESOURCES**

### **ARTICLE 24: RESOURCES**

The resources of COEUR DE ROSE come mainly:

- Membership fees which are set at 3 euros;
- Monthly contributions which are fixed at 1.5 Euros

; The children did not pay a membership fee and pay an annual fee of 1.5 Euros

- Grants and donations.

### **ARTICLE 25: BUDGETARY YEAR**

The fiscal year of COEUR DE ROSE begins on January 1st and ends on December 31st of the current calendar year.

### **ARTICLE 26: DEPOSIT OF FUNDS**

The COEUR DE ROSE funds are deposited in a bank approved by the board of directors and in an account opened for this purpose.

### **ARTICLE 27: FINANCIAL MOVEMENTS**

Opening of accounts and withdrawal of funds must include the signature of the President:

- That of the President or, in case of absence or impediment, that of the Secretary General and
- The Treasurer General or the absence or incapacity of the Assistant Treasurer General.

## **TITLE V: FINAL PROVISIONS**

### **ARTICLE 28: FUNCTIONS**

The functions performed in the different organs of COEUR DE ROSE are free (Volunteers). However, the General Assembly sets reimbursement rates for travel expenses, missions or internships carried out by members of COEUR DE ROSE as part of their duties.

#### **ARTICLE 29: AMENDMENT OF STATUTES AND DISSOLUTION OF THE ASSOCIATION**

The modifications of the statutes and the dissolution of CŒUR DE ROSE in accordance with article 10, are proposed to the general assembly by:

- The board of directors or;
- 2/3 of the active members of the NGO.

They intervene under the conditions provided for in article 12 of these statutes.

#### **ARTICLE 30: LIQUIDATION**

In case of dissolution, the general assembly appoints a commissioner responsible for the liquidation of the property of the NGO.

Net assets are allocated to a charity.

#### **ARTICLE 31: RULES OF PROCEDURE**

The rules of procedure will determine the conditions of application of these statutes.

# **RULES OF PROCEDURE**

## **TITLE I GENERAL PROVISIONS**

### **ARTICLE 1**

The purpose of these rules of procedure is to define the modalities of application of the statutes of the NGO.

## **TITLE II**

### **ACQUISITION AND LOSS OF QUALITY OF MEMBERS**

#### **CHAPTER I: STATUS OF MEMBERS**

The NGO is composed of active members and honorary members

#### **ARTICLE 2: ACTIVE MEMBERS**

Active members are founding members and people who:

- Have made a written request to this effect;
- have adhered to the statutes;
- They paid part of their dues and part of their annual dues.

THE ADESION OF CHILDREN AND YOUNG GIRLS IS PRIORITY FOR ANY OTHER APPLICATION FOR MEMBERSHIP

#### **ARTICLE 3: MEMBERS OF HONOR**

Honorary members are individuals who have rendered, render or are capable of rendering exceptional services to the NGO.

#### **CHAPTER II: ACCESSION AND EXCLUSION**

#### **ARTICLE 4: ACCESSION**

Anyone who has applied for membership or any association, a non-governmental organization (NGO) legally incorporated in Côte d'Ivoire, can join COEUR DE ROSE.

#### **ARTICLE 5: EXCLUSION**

Membership is lost by:

- Resignation;
- Exclusion;
- Deaths;
- Dissolution of the NGO or association.

### **TITLE III**

#### **RIGHTS AND DUTIES OF MEMBERS**

##### **CHAPTER I: RIGHTS AND OBLIGATIONS OF MEMBERS**

###### **ARTICLE 6: RIGHTS OF MEMBERS**

Active membership confers the right to participate in the deliberations of the general assembly.

Active members have the duty to:

- Pay their various contributions;
- Participate in all meetings;
- Respect the decisions and deliberations of the board of directors and the general assembly.

###### **SECOND CHAPTER: SANCTIONS**

Failure to comply with the obligations laid down in Article 7 of this Regulation entails the following penalties:

- Warning
- Blame
- Exclusion.

###### **ARTICLE 8: SANCTIONS OF FIRST DEGREE**

The warning and the blame are pronounced by the board of directors.

###### **ARTICLE 9: SANCTIONS OF SECOND DEGREE**

The exclusion is pronounced by the general assembly.

### **TITLE IV**

#### **ADMINISTRATION AND OPERATION**

The association has the following organs:

- The General Assembly;
- The Board of Directors;
- Statutory Auditing.

## **ARTICLE 10: COMPOSITION**

The general assembly is composed of all the active members. Honorary members may attend and be heard at COEUR DE ROSE sessions, unless the latter object but are not entitled to vote.

## **ARTICLE 11: RESPONSIBILITIES**

The General Assembly is the supreme organ of COEUR DE ROSE. Its main functions are:

- Determine the general policy of Coeur de rose;
- Control the financial policy, review and approve the budget and financial regulations of COEUR DE ROSE;
- Decide on the membership of new members of COEUR DE ROSE and determine the nature of their rights and obligations;
- set the contribution rate and the annual contribution rate;
- To modify the statutes and to create any other organ necessary for the good functioning of COEUR DE ROSE;
- elect the president and the auditors;
- appoint the liquidators of CŒUR DE ROSE;
- Move the seat of Coeur de rose;
- Take all necessary steps to achieve the objectives of COEUR DE ROSE.

## **CHAPTER TWO: THE BOARD OF DIRECTORS**

### **ARTICLE 12: COMPOSITION**

The Board of Directors comprises 30 members. It is constituted as follows:

- The presidency composed of the president and two vice-presidents
- The General Secretariat composed of the Secretary General and 2 deputies
- Secretariat of the Organization composed of the Secretary of the Organization and 2 deputies
- The General Treasury composed of the Treasurer General and 2 deputies
- The Resources Secretariat composed of the Secretary RESOURCES and 2 deputies
- Access and Volunteer Secretariat composed of the Secretary of the Members and 2 deputies
- Secretariat of Communication and Partnerships composed of the Secretary of Communications and 2 deputies
- the Secretariat for Social and Cultural Affairs composed of the Secretary for Social and Cultural Affairs and two deputies
- 3 special advisors

### **ARTICLE 13: RESPONSIBILITIES**

The functions of the members of the board of directors are as follows:

- **PRESIDENT:** The president is the head of the board of directors.

As such:

- It convenes the general meetings and the meetings of the Board of Directors and ensures the application of the deliberations and decisions taken
- It represents the NGO in all acts of civil life and is vested with all powers for this purpose;
- In particular, he has standing to act on behalf of Coeur de Rose COTE D'IVOIRE.

He is assisted by 2 deputies

- **SECRETARY GENERAL:**

The Secretary General is the administrative head of Coeur de Rose. As such:

- Prepares the minutes of the deliberations and decisions of the general meetings and the meetings of the board of directors and ensures their transcription in the register provided for this purpose;
- He writes all the correspondences of COEUR DE ROSE;
- He is in charge of the archives of Coeur de Rose.

He is assisted by 2 deputies

- **The Secretary of the Organization:**

he is responsible for organizing the activities of Coeur de Rose, it ensures their proper functioning. He is assisted by 2 deputies

- **TREASURER GENERAL:**

The Treasurer General is the financial director of Coeur de Rose. In particular, he is responsible for collecting contributions. He is assisted by 2 deputies

- **The Secretary of Resources:**
